Note:

1. A complaint from an aggrieved student relating to the institution shall be addressed to the Chairperson,
2. The term of the chairperson and members shall be for a period of two years or till further order.

3. The term of the special invitee shall be one year or till further order.
4. The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
5. In considering the grievances before it, the SGRC shall follow principles of natural justice.
6. The SGRC shall send its report with recommendations Hon'ble Vice Chancellor through Registrar the University a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.
7. Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.
8. This constituted committee will function w.e.f. the date of issue of this Office Order.
